MINUTE OF PREVIOUS AGM

The minute was accepted as accurate and was proposed by Miss L McFarlane, and seconded by Mr T Woodford

CHAIRMANS REPORT

A copy of the chairman's report was distributed to all present and will be printed in the Inchture News Letter and on the Community Council website. A brief discussion took place on some of the issues covered in the report.

Matters arising from the discussion were that P Henderson was nominated to attend the discussions between P&K Council and the community councils regarding changes to the constitution of the CC's

TREASURERS REPORT

A copy of the accounts was available for all present. The treasurer went through the account in detail and these were approved.

CHANGES TO MEMBERSHIP

There were no changes to the membership of the council. All members agreed to remain with their current portfolios until the election in June. This meant that there were still 2 vacant positions on the council for the Parish of Rait, a member of the public asked if it would be possible to allocate one of these positions to Ballindean. S Kelly-Barton is to contact Brenda Lackie at P&K Council to clarify this.

BUSINESS

The proposal to change the constitution of the community council to that proposed by P&K Council was unanimously agreed.

An application from Fingask Castle to make an amendment to its premises license was discussed. It was agreed that S Kelly-Barton would contacted the Licensing Standards Officer at P&K Council, Harry Dunn, to clarify what the amendment was.

A request from Peter Lyburn, Conservative Party candidate for our area at the General Election, for the community to arrange a hustings had been received. A response was sent stating that the Community Council was a non-political voluntary organisation and as such we did feel that it was within our remit to organise such an event.

The application to take ownership of the telephone box at Kinnaird was discussed. Concerns were raised over the extent of the cover given by our Public Liability Insurance. It was decided that S Kelly-Barton would contact Brenda Lackie to find out if we were covered in the event of an accident.

A letter had been received from BEAR Scotland regarding the closure of the central reserve at Middlebank on the A90. Background information had been provided by owners of Middlebank and after a discussion it was agreed that T Woodford would contact BEAR stating that we had no objection to the closure provided that the road to the rear of the farm connecting to the new road at Westown was upgraded to a suitable standard.
